Section 1. Pursuant to the provisions of Sec. 533 of the County Law of the State of New York, the County of Orleans hereby assumes the liability to save harmless the Orleans County Clerk and employees of the County Clerk's Office from financial loss arising out of any claim, demand, suit or judgment by reason of alleged negligence of said county clerk or employees, provided such act was committed in the discharge of their duties and within the scope of their employment.

Section 2. The County of Orleans shall arrange for the purchase and maintain appropriate insurance with any insurance company authorized to do business in the State of New York for coverage against such liability.

Section 3. This local law shall become effective upon its being filed in the Office of the Secretary of State of the State of New York following its approval as is provided by the Municipal Home Rule Law.
