Section 1. That in addition to the duties of the Orleans County Sheriff as established by the laws of the State of New York, the Orleans County Sheriff is also named Controller of Animals and the Orleans County Sheriff shall as of the effective date of this Local Law assume the duties of such Controller of Animals.

Section 2. Pursuant to the provisions of the Municipal Home Rule Law of the State of New York, the salary of the Orleans County Sheriff is hereby increased from \$13,500.00 to \$15,000.00 per annum.

Section 3. This Local Law is adopted subject to referendum on petition pursuant to Section 24, Subdivision 2-h of the Municipal Home Rule Law of the State of New York.

Section 4. This Local Law shall take effect 45 days after adoption hereof or after approval by the affirmative vote of a majority of the qualified voters of the County of Orleans voting on a proposition for its approval, whichever event first occurs. Provided, however, that in no event shall this Local Law take effect prior to January 1, 1974.
