Local Law No. 2 of the year 19 84

A local law AMENDING LOCAL LAW NO. 2 of 1956 WHICH ENUMERATED RULES AND REGULATIONS FOR THE ADMINISTRATION OF THE ORLEANS COUNTY SELF-INSURANCE PROGRAM

Be it enacted by the Orleans County Legislature of the (Name of Legislative Body)

SECTION 1. Subdivision C of Section 1 of said Local Law No. 2 of 1956 entitled "Apportionment of Costs" is hereby amended to read as follows:

a.) Ninety percent (90%) of the annual estimate of expenses shall be apportioned among the participants in the proportion that the full valuation of each participant bears to the aggregate full valuation of all the participants for fiscal year 1985; eighty percent (80%) of the annual estimate of expenses shall be apportioned among the participants in the proportion that the full valuation of each participant bears to the aggregate full valuation of all participants for fiscal year 1986; and seventy percent (70%) of the annual estimate of expenses shall be apportioned among the participants in the proportion that the full valuation of each participant bears to the aggregate full valuation of all participants for fiscal year 1987 and for each succeeding fiscal year thereafter.

b.) Ten percent (10%) of the annual estimate of expenses shall be apportioned among the participants according to a computer formula experience rating based on the three consecutive calendar years immediately preceding the year in which said estimate is presented and approved for the fiscal year 1985; twenty percent (20%) of the annual estimate of expenses shall be apportioned among the participants according to a computer formula experience rating based on the three consecutive calendar years immediately preceding the year in which said estimate is presented and approved for the fiscal year 1986; and thirty percent (30%) of the annual estimate of expenses shall be apportioned among the participants according to a computer formula experience rating based on the three consecutive calendar years immediately preceding the year in which said estimate is presented and approved for the fiscal year 1987 and for each succeeding fiscal year thereafter.

SECTION 2. This Local Law shall take effect immediately upon filing in the Office of the Secretary of State, but shall first effect the 1985 Orleans County Self-Insurance Plan Budget.
