RESOLUTION ADOPTING LOCAL LAW NO. 3 OF 1992 ENTITLED A LOCAL LAW INCREASING THE SALARIES OF VARIOUS EMPLOYEES OF THE COUNTY OF ORLEANS APPOINTED OR ELECTED FOR A DEFINITE TERM

WHEREAS, Local Law No. 3-Intro of the Year 1992 was introduced at a regular meeting of the Orleans County Legislature held on May 27, 1992, and a public hearing was held on June 10, 1992 at which time all interested persons wishing to speak were heard, be it enacted as follows:

COUNTY OF ORLEANS
LOCAL LAW NO. 3 OF THE YEAR 1992

A LOCAL LAW INCREASING THE SALARIES OF VARIOUS EMPLOYEES OF THE COUNTY OF ORLEANS APPOINTED OR ELECTED FOR A DEFINITE TERM

BE IT ENACTED by the Legislature of the County of Orleans as follows:

Section 1. Pursuant to the provisions of the Municipal Home Rule Law of the State of New York, the salaries of the following County Employees are raised as follows, per annum, January 1, 1992:

<u>Employee</u>	<u>Proposed Salary</u>	<u>Longevity Bonus</u>	<u>Total Salary</u>
County Clerk	\$35,455	-----	\$35,455
Sheriff	43,075	**\$650.00	43,725
Highway Superintendent	40,744	** 650.00	41,394
Director of Personnel	32,617	-----	32,617

** Indicates 20-25 yrs. of service. This longevity bonus shall be paid in the payroll next following the employee's anniversary date.

Section 2. This local law is adopted subject to referendum on petition pursuant to Section 24, Subdivision 2-h of the Municipal Home Rule Law of the State of New York.

Section 3. This local law shall take effect 45 days after adoption thereof or after approval by one affirmative vote of a majority of the qualified voters of the County of Orleans voting on a proposition for its approval, after petition, whichever event first occurs.
