Local Law No. 4 of the year 19 92

A local law AUTHORIZING THE ORLEANS COUNTY PROBATION DEPARTMENT, WHEN ORDERED, TO CONDUCT AN INVESTIGATION UNDER THE FAMILY COURT ACT, TO BE ENTITLED TO A FEE OF NOT LESS THAN FIFTY DOLLARS (\$50.00) AND NOT MORE THAN FIVE HUNDRED DOLLARS (\$500.00) FROM THE PARTIES IN SUCH PROCEEDING.

SECTION 1. This Local Law is authorized by Section 252-a of the Family Court Act of the State of New York.

SECTION 2. The Orleans County Probation Department when it is ordered to conduct an investigation pursuant to Section 653 of the Family Court Act of the State of New York shall be entitled to a fee of not less than Fifty Dollars (\$50.00) and not more than Five Hundred Dollars (\$500.00) from the parties in such proceeding for performing such investigation.

SECTION 3. The fee provided for in Section 2 of this Local Law shall be based on the parties' ability to pay such fee and the schedule for payment shall be fixed by the Family Court issuing the Order for Investigation, pursuant to the guidelines issued by the Director of Probation and Correctional Alternatives, and may in the discretion of the Court, be waived when the parties lack sufficient means to pay the fee. The Court shall apportion the fee between the parties based upon the respective financial circumstances of the parties and the equities of the case.

SECTION 4. Fees pursuant to this Local Law shall be paid directly to the Orleans County Probation Department to be retained and utilized for local probation services, and shall not be considered by the New York State Division of Probation when determining State Aid Reimbursement pursuant to Section 246 of the Executive Law of the State of New York.

SECTION 5. This Local Law shall take effect immediately upon filing by the Secretary of State of the State of New York.
